

A RESOLUTION AUTHORIZING THE DISTRICT'S BUDGET FOR THE FISCAL YEAR 2018-19, CREATING EXPENDITURE APPROPRIATIONS, SETTING THE TAX, AND IMPOSING THE TAX

BE IT RESOLVED that the Board of Directors of the West Multnomah Soil & Water Conservation District hereby adopts the budget for fiscal year 2018 - 2019 in the total amount of: \$3,028,741 This budget is filed with the Tax Supervising & Conservation Commission (TSCC) in Portland, Oregon.
