

West Multnomah Soil & Water Conservation District (SWCD) Board Meeting Minutes 04/20/2021

# 1. Meeting Location and Time:

Location: Held via Zoom meeting. The meeting was called to order by Director Preeg Riggsby at 8:00 PM.

# 2. Introductions and Agenda Approval

Directors Present: Hartline, Lightcap, Looney, Miller, Peterson, Preeg Riggsby, Sowder; Associate Directors Present: Hamer; District Manager (DM): Cathcart; Staff: Razalenti

It was announced that the Board meeting would be recorded. The agenda was approved by acclamation, with the addition that Director Lightcap wanted to make a report (resulting in a Director check-in agenda item).

#### 3. Minutes:

West Multnomah SWCD Board Meeting minutes from 3/16/2021<sup>i</sup>
Director Lightcap made a motion to approve the Board meeting minutes from 3/16/21 as written, and Director Looney seconded the motion. The motion was approved with a vote of 7-0.

Director Miller reported that the District is in a good position going into the next fiscal year.

## 6. Support for Recovering America's Wildlife Act<sup>v</sup>

DM Cathcart gave the Board an overview of the backgrounder handout of the Recovering America's Wildlife Act and the National Wildlife Federation's group letter that DM Cathcart recommended the District join as a signatory in support for this Act. Director Lightcap noted that the Oregon Association of Conservation Districts (OACD) should also share this letter with other SWCDs to sign on. Director Preeg Riggsby, as President of OACD, will follow-up with OACD on this.

Director Hartline made a motion to sign the letter supporting the Recovering American's Wildlife Act. Director Looney seconded the motion, and it was approved with a vote of 7-0.

### 7. Juneteenth as a District Holiday

Director Preeg Riggsby reminded the Directors of the motion made in June 2020 regarding the Board's intention to review declaration of Juneteenth as an annual holiday for future years at a subsequent

meeting. The DEI Committee [as well as all staff at their April staff meeting] discussed the notion of swapping out observing Presidents' Day for Juneteenth to keep the number of paid holidays remaining the same, and were supportive of this. It was also noted that the State of Oregon was voting on a bill to make Juneteenth a state holiday but that the Board still needed to take action to observe this day as a holiday because the District is not obligated to follow all state holidays. Staff impacted by children being off from school for Presidents' Day have access to personal time or other forms of leave such as vacation time, should they need to use this to cover child care for Presidents' Day.

Director Miller made a motion to approve making Juneteenth a paid holiday in place of Presidents' Day. For this particular year (2021), Juneteenth can be an additional holiday due to Presidents' Day having already been observed. Director Looney seconded the motion, and it was approved with a vote of 7-0.

#### 8. Director check-in

Director Lightcap noted noticing garlic mustard in Connecticut, and is planning to help eradicate the garlic mustard with local neighbors.
