1. Meeting Location and Time:

District Conservationist Galland reported that she is in the process of filling two open Soil Conservationist positions. She also updated the board on the Black Food Sovereignty Coalition's emergency of having a broken pump and not being able to irrigate their crops. Various options are being considered to assist, and Kern-Korot will reach out to BFSC leadership this week to identify what assistance would be most helpful.
