

West Multnomah Soil & Water Conservation District (WMSWCD) Board Meeting Minutes 10/18/2022

1. Meeting Location and Time:

Location: Held via Zoom meeting. The meeting was called to order by Vice Chair Sowder at 6:02 PM.

2. Introductions and Agenda Approval

Board members reviewed the West Multnomah SWCD Board Meeting minutes from 9/20/2022.ⁱⁱⁱ

Director Looney made a motion to approve the Board meeting minutes as written, and Director Miller seconded the motion. The motion was approved with a vote of 5-0.

The Board watched a recorded training put on by Special Districts Association of Oregon (SDAO) regarding Board & District Manager relationship, roles, and responsibilities ^{III}. This training is part of SDAO's recommended best practices this year. The board training both allows us to mitigate risks and receive a discount on property and liability insurance. Staff member Levis also reminded the board about the SDAO Leadership Academy for board members and will be sending program and enrollment information to all board members. Director Lightcap confirmed he would be enrolling.

8. Director and Associate Director Check-ins

Director Hamer commented that he had enrolled in the Leadership Academy and found the courses excellent. He also stated that the training the board had just watched reflected what a great fit Jim Cathcart had been in the District Manager role.

Director Lightcap asked if current Sturgeon Lake fish monitoring data was available on the website or could be sent to him. Staff member Levis will be following up with staff to get the most recent data to Director Lightcap.
